## **Catering Contract**

The Caterer reserves the right to substitute items unavailable for reasons of shortage or excess price increase for events contracted more than 6 months in advance, the quoted price may be adjusted to accommodate food increases. The caterer will not be held responsible for losses due to strike, labor dispute, inclement weather or any other occurrence beyond his/her control.

The host agrees that in the event of cancellation of the affair by the host for any reason whatsoever, that planning services have been rendered, various expenses have been incurred and that the date of the affair has been set aside for exclusive use of the host by the caterer. Both parties agree that if the affair is canceled by the host more than 30 days before scheduled event, caterer shall be entitled to retain Fifty percent (50%) of the contracted price, and if canceled between 8 - 30 days before the scheduled event, than Seventy-five percent (75%) of the contracted price will be paid by the host. Final balance is due no later than 7 days before the event date. No refunds will be given if event is cancelled within 7 days of the event date. If the event is **postponed**, **not cancelled**, before we are 8 days from the event date, the deposit will be credited to the new date if rescheduled within 6 months.
